

# NON IMMIGRANT VISA APPLICATION

## REQUIREMENTS

**ALL** visitors must travel to Belize on a valid passport (non-expired). The passport must be valid for no less than **SIX** months after the intended period of stay in Belize.

Nationals of the following countries do **NOT** require a visa to enter Belize as a tourist for a period of 30 days.

Citizens of the European Union Member States (EU) and their dependent territories.

Citizens of the Caribbean Community Member States (CARICOM) with the exception of Haiti.

Citizens of the United States of America and dependent territories.

Citizens of Costa Rica, Chile, Guatemala, Iceland, Mexico, Norway, Tunisia & Uruguay

Citizens of the Commonwealth Realms & Monarchies, and their dependent territories.

Citizens of the Commonwealth Republics **with the exception of the following**

Bangladesh

Nauru

Cameroon

Pakistan

Chad

Sri Lanka

India

Nigeria

Mozambique

Nationals of **ALL** other countries **REQUIRE** a visa to enter Belize. Visas are issued within two weeks. Some applications require authorization from the Department of Immigration and Nationality in Belize. In such cases, please allow 1 - 2 weeks for processing. Each individual, regardless of age, must make a separate application.

The application form **MUST** be FULLY completed, signed and dated, then submitted with the following:

**1. A Copy of data page of passport**

**2. One recent passport-sized photograph**

**3. Proof of Travel Arrangements:**

Travel Itinerary

**4. Proof of Accommodation:**

Copies of Hotel Reservations or Full contact details of family/friends in Belize

**5. Proof of Financial Means:**

Copies of most recent bank statement or Letter from Financial Officer (for Business travel only)

**6. Purpose for Trip:**

Educational - Letter of Admission from University or Educational Institution

Business - Letter of Introduction from Company or Organisation and supporting documents

Tourism - *see number 3 above.*

**7. Payment of Fees:**

**Visa Fee**

Visa Fee is \$60 or NGN10800.00 (valid for 3 months from the date of issue)

Payment must be made at GTBank.

**Note: The Consulate of Belize cannot guarantee that the visa will be processed within two weeks and will not accept liability for any loss incurred as a result of delays in processing or delivery.**
